Ivy Hill History

Karl Hehl and his wife, the last private owners of Ivy Hill, sold the estate to Black Watch Farm. Black Watch Farm was a large New York based farming operation that raised primarily black angus cattle. During the years that they owned the land, it was strictly a cattle ranch. The cowboys bunked in what is now the Ivy Hill Realty office and the other out buildings around the farm. No one lived in the main house. In fact, it stood open to the elements for many years, and the cattle wandered freely around on the ground floor.

In 1970 Allen and Fern Harvey purchased Ivy Hill and began its transformation into a planned community. However, this transformation naturally didn't occur overnight. As the development pushed slowly and methodically inward from the south and the west, the low-lying land to the north and the east continued to be used as a cattle ranch. Even the golf course got into the act. The rough was often allowed to grow two feet high or more, and then the hay was harvested to feed the cattle. Imagine trying to hit your ball out of two feet of grass! (Imagine even trying to find it!) There was a real premium on straight drives in those early years.

The barn shown in this old painting stood near Ivy Creek in the valley below the main house. In the 1970's and early 1980's it was used primarily to store hay for the cattle. The site is now underwater at the bottom of Ivv Lake. The barn was located in what is now the deepest part of the lake, just north of the center of the dam. (If the current effort to lower the level of the lake progresses far enough. its ruins may become visible.)

By-laws Amendment Approved Overwhelmingly

The proposal to amend Article II, Section 4 of the IHHA Bylaws to give the Board of Directors the option to conduct all business normally conducted at the Annual Meeting via written or electronic communications received a greater than 99% favorable vote. The final tally when voting was cut off on December 31st was 138 YES to 1 NO.

Per Article V, Section 6 of the By-Laws as currently amended, the IHHA By-laws may be amended only by the affirmative vote of members representing thirty-five percent (35%) of the total lots whose owners are members of the Association. We had 312 paid members at the end of 2013. So we needed 110 "Yes" votes to make this change to the By-laws. As 138 is significantly greater than 110, the proposed amendment has been adopted.

IHHA 2014 Ballot

The IHHA Board has elected to try out the new option to conduct all business formerly conducted at the Annual Meeting via written or electronic communications. The ballot below is part of that trial as are the various financial reports that you will find on pages 6 and 7 of this Newsletter.

Your 2014 ballot lists twelve candidates that have agreed to stand for election to the IHHA Board of Directors. You can cast your ballot electronically or by mail. The Committee found that all of the records were prepared in accordance with accepted accounting practices, and with but one minor omission (subsequently corrected by Treasurer Bob Harvey) were accurate and acceptable.
